

PROPERTY COMMITTEE OCTOBER 20, 2022

The property committee had a cleanup day on October 15. 18 volunteers showed up and did a fantastic job of sprucing up the outside grounds. Weeds and debris was cleared from the junipers facing Forest Drive and shrubs pruned to improve the curb appeal and first impression of GSLC. There are several bald spots where shrubs have died and need to be replaced next Spring.

Dominion Energy has proposed an update to all 3 buildings (FAB, education, and sanctuary) with LED lighting. The projected cost is less less in Dominion incentives. Our net cost is and the energy savings is projected to be year for all 3 buildings. This translates to a 2-year break even in cost.

A paving company was contacted to get estimates for resurfacing our parking areas. It is taking more and more time to spray chemicals and alternatives are being sought. The quote has 3 parts: crack seal, asphalt repair, and sealcoating with striping. (Striping means re-painting the parking lines and arrows of our facility.) If all 3 components are contracted, the cost will be ______. Copies of the quote are attached.

The property committee has been researching the cost to have a well installed for watering the grounds, but a comprehensive cost estimate has not been finalized. We plan to use the funds from Carol Mayfield's bequest, and the Memorials to complete the job. Loose estimate at this time is about to do the job.

The church bus has been repaired and some routine maintenance recently completed so thing should be in good working order for the foreseeable future.
